**The Birds and the Bees**

A male/female relationship is one forged in nature by the Creator and is a steadfast rule that cannot be broken.

In the book of Genesis, God describes the marriage act when he created a “help meet” for Adam (Gen 2:18 KJV). That term is derived from the original Hebrew, *kanegadu* which is a compound word meaning, “like man, but the opposite.” Hence, the difference in genders shows a physical opposite as well as the not so obvious psychological opposite. The two were intended to compliment each other in nature with procreation of course being the obvious outcome, but also the energy between the two—male and female—complimenting each other to become a whole unit.

Microphone connectors exist as both female (left) and male (right). Two males or two females cannot join to create a connection. Only a male and female can (below).



The 1/4” male plug (right) and 1/4” female jack (left) are used in line level and speaker system integration.



Two 1/4” male plugs will not connect with each other (above) any more than two female jacks.

The only way to integrate the two 1/4” components is with a male and female connector (below)



RCA type male and female connectors (above) transport line-level signals from CD players, MP3 players or other audio sources. They, too, only work in a male/female arrangement.



Other places in sound systems where male/female unions apply are in the clutch mechanism of a microphone stand (left) and the connection of a compression driver to its horn, which can only be a male/female union (below).



The male/female union exists just about everywhere. We see it in power cords:



Bottle caps and bottles



Nuts and bolts (left), and door latches and door catches (below)

These gender differences do not indicate any superiority of one over the other. Rather, it shows how the two work together to compliment each other to complete the task they were designed for. For example, regardless of how beautiful the music is, or how much love one has for the connectors,

no music can flow in the sound system and nothing can be heard or enjoyed if one tries to interconnect it with all one gender. Every connector point in a sound system requires a male/female union and this rule cannot be disobeyed.

The male/female union between a bottle and its cap create a situation wherein the liquid inside is preserved from evaporation. The nut and bolt are a male/female union that holds on a wheel or holds up a skyscraper. The door latch and catch work together to secure the door. These are all actions that could not take place if not for the differences in genders joining together to form a union that completes the task they were designed for.

Homosexual men who claim they can interconnect as if they were male and female, through a corrupted physical union with each other, are missing the whole concept of the male/female union to begin with. It is not about sexual pleasure, or physical integration, that is only a part of it.
